1. The Ministry of Works And Transport has allocated funds for the Supply and Delivery of Road Signs under frame work contract for a period of 18 months.
2. The Entity invites sealed bids from eligible bidders for the Provision of the above supplies.
3. Bidding will be conducted in accordance with the Open *Domestic* Bidding method contained in the Public Procurement and Disposal of Public Assets Act, Cap 205 and the Regulations made under the Act and is open to all bidders .
4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from 8:00a.m – 5:00 p.m. .
5. The bidding document which has been prepared in the English language may be purchased by interested bidders at 8(a) upon payment of a non-refundable fee of UGX 100,000 (Uganda Shillings One hundred thousand only). The method of payment will be registering the payment on the Uganda Revenue Authority (URA) website portal. Print the payment advice Form after registering on the URA Portal and effect payment through the URA collection Banks.

Bids must be delivered to the address below at 8(c) at or before 24/03/2026 at 11:00 a.m. All bids must be accompanied by a bid security of 50,000,000/= (fifty million shillings only) Bid securities must be valid until 23/10/2026. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(c) on 24/03/2026 at 11:30 a.m.
