5. The Bidding documents may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of **UGX 100,000/= (Uganda Shillings One Hundred Thousand Only) to a local bank.**
6. Bids must be delivered to the address below at 8(c) at or before 11.00 a.m. on 23<sup>rd</sup> April, 2026. All bids must be accompanied by a bid security i.e. **Lot 1:** UGX. 6,500,000 (Uganda Shillings; Six Million Five Hundred thousand Only) and **Lot 2:** UGX. 6,500,000 (Uganda Shillings; Six Million Five Hundred thousand Only).
