Bidding will be conducted in accordance with the procedures contained in the Public Procurement and Disposal of Public Assets Act (the Act) Cap 205 and the Regulations made under the Act. **Lot 3 is Open to all bidders. Lot 1,2,4,5,6 are reserved for Resident and EAC Providers whereas Lot 7,8 and 9 are reserved for National providers.**

Bids for **Lot 1,2,4,5,6,7,8,9** must be accompanied by a bid securing Declaration valid until **2nd March 2027** and the bids for **Lot 3 must be accompanied by a Bid security of UGX 250,000,000 valid until 2nd March 2027.** Electronic bidding *will not* be permitted. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at **8(d) on 17th August 2026 at 11;30am.**
