Bids must be delivered to the address below at 8(c) at or before **11:00am** on the **3rd August 2026.** The bid must be accompanied by a **bid Security of UGX 70,000,000 (Seventy Million Shillings Only).** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **11:30am on the 3rd August, 2026.**
